Did You Know?

Mobi PCS offers wireless service discounts through federal Lifeline programs.

What is Lifeline?

The Lifeline program is designed to provide federal assistance to qualifying households/individuals. Mobi PCS is a Hawai'i wireless service provider that is able to allow customers who qualify to participate in this discount program.

If your household income is below the Hawai'i-specific threshold or if you participate in certain federal assistance programs, you can receive monthly discounts on your Mobi PCS phone service.

How much of a discount can I receive?

The recurring Lifeline discount for Mobi PCS service is \$13.50 per month.

Who is eligible for this discount?

You are eligible if you participate in at least one of the following programs:

- Medicaid
- Supplemental Nutrition Assistance Program
- Supplemental Security Income
- Low-Income Home Energy Assistance Program
- Federal Public Housing Assistance or Section 8
- National School Lunch - Free Lunch Program
- Temporary Assistance for Needy Families

You may also qualify for this program on the basis of your household income.

How can I receive the Lifeline discount from Mobi PCS?

To receive the Lifeline discount, follow these steps:

1. Determine your eligibility for this program. Review the form in this brochure to determine if you qualify.
2. Complete all 5 sections and sign the certification form in this brochure. Print clearly and provide accurate information.
3. Gather copies of all necessary documentation. Qualification through household income level requires supporting documents to confirm your income status.
4. Mail, fax, or bring the certification form and supporting documents to your nearest Mobi PCS retail store.
